Subject: Domain name Registration

Sir/Madam.

This is in continuation to CBSE Letter no. CBSE/AFF./DS/2013/599475 dated 29.8.2013 requesting all the schools to develop their own websites containing comprehensive information about the schools. In this regard it is to inform that ERNET India is an autonomous organisation under Ministry of Communications and IT, Govt. of India and is an exclusive domain registrar for registering the domains under the .IN registry since 2005 and operates under the authority of National Internet eXchange of India (NIXI). ERNET registers domain name under ac.in, edu.in for schools. In order to have meaningful uniformity across the schools, the CBSE advises schools to register their domain under ac.in and edu.in. The steps for registration are given below:-

- 1. School has to send request letter, telling the domain name to be registered (e.g. schoolname.ac.in or schoolname.edu.in e.g. dpsramgarh.ac.in, dps-ramgarh.ac.in davalipur.edu.in, dav-alipur.edu.in etc) to ERNET India along with registration charges in the form of DD in favour of ERNET India payable at New Delhi.
- 2. Domain will be registered for 5 years. Charges for registering domain for 5 years are Rs. 3371/- Domain can also be registered for 1 year @ Rs. 750/- + ST or 2 years @ Rs. 1350/- + ST.
- 3. Schools has to fill online registration form through ERNET registry website <a href="https://www.registry.ernet.in">www.registry.ernet.in</a>
- 4. While filling online form school has to fill details like amount, DD no. date etc. 'So DD should be prepared before filing online form.
- 5. In online form user has to provide Primary name server and Secondary name server (dns server) which will be maintaining domain of the school i.e. where the school's website will be hosted. These name servers can be either of ERNET or school may take DNS services from any local vendor of their area.
