Subject: NCFM Online Tests for students of FMM

Dear Principal,

As per the scheme of studies of Financial Markets Management (FMM) vocational course earlier students were required to appear in 3 NCFM (NSE's Certification in Financial Markets) Modules. CBSE vide circular no. EO/V&E/FMM/CBSE/2009 dt. 5<sup>th</sup> November 2009 (enclosed) has intimated the detailed procedure for registration of NCFM examination and remittance of fees to National Stock Exchange (NSE).

As you may be aware, as per the new scheme of studies for vocational courses and FMM, students are required to appear for 4 NCFM modules instead of 3 module from the session 2013 -14 onwards. The 4<sup>th</sup> module of Mutual Funds has been added in the 11<sup>th</sup> class for which the module fees is Rs.500/-. An updated list of names of the CBSE papers with equivalent NCFM module and NCFM examination fees to be paid to the NSE is given below.
