- 3. Students can use any type of paper of A4 size and can use oil/pastel/water colour as per their choice.

- 5. The States and the UTs would follow their own procedures and timeline for conduct of the competition and collation of entries for uploading the best 20 entries on the MHRD website by **24.01.2017**.
- 6. No cash prizes are to be given to the winning students. However, participating children would be given e-Certificate of Participation and best winning entries would be given e-Certificate of Merit.
- 7. Heads of schools are requested to encourage their students to participate in the competition.
- 8. The entries would be adjudged on the basis of originality of expressions, presentation, relevance to the topic and technique.

- 11. The entries not received as per the time-line mentioned at point no 4 above will not be entertained. Also, the entries received through e-mail will not be considered.
- 12. No correspondence with regard to the declaration of result or winning entry will be entertained under any circumstances.
