2. It was specifically mentioned in the aforesaid advertisement that, before applying to the post(s), the interested candidates must satisfy themselves and ensure that they fulfil essential criteria as per Recruitment Rules and other conditions mentioned in the advertisement.

3. The candidate were provisionally allowed to appear in the Computer Based Test (CBT) based on the information submitted by them online, without ascertaining their eligibility for the respective post(s).

4. The Board published, list of provisionally shortlisted candidates for further selection process vide Result Notice No: CBSE/Rectt.Cell/14(85)/DR/2020/3391-3490 dated 16.10.2020 based on their performance in the Computer Based Test (CBT). The candidates were directed to present on the specified date for interview along with their originals documents and testimonials. Before interview, the documents of the candidates were verified and ascertained their eligibility for the post and only thereafter, the candidates were allowed to appear in the interview.

5. Further, following candidates of the reserve panel & found provisionally eligible were asked to submit their supporting documents for finalization of their eligibility in terms of experience/educational qualification as per the Recruitment Rules of the respective posts. After the scrutiny of the documents, these provisionally shortlisted candidates were not found eligible, as they did not fulfil the essential eligibility criteria and/or experience of in the Recruitment Rules for the post(s) applied and other conditions of the advertisement:
