### NOTIFICATION

**Sub: Cancellation of candidature to the post of Junior Assistant –reg.**

The Board vide Corrigendum No. CBSE/Rectt.Cell/14(85)/DR/2022/180649 dated 24.05.2022, Result Notice No. CBSE/Rectt.Cell/14(85)/DR/2022/1855310 dated 21.09.2022 and No. CBSE/Rectt.Cell/14(85)/DR/2022/1857640 dated 11.11.2022 has provisionally shortlisted following 03 candidates for appointment to the post of Junior Assistant. During the process of document verification, it has found that these candidates have not submitted their valid caste certificate for employment in organisations of Central Government on crucial date of eligibility i.e. closing date for receipt of online application i.e. 16.12.2019 as mentioned in advertisement dated 15.11.2019. The details of candidates are as under:-

2. Further, in pursuance to Para-3 of DoPT OM No.36033/4/97-Estt. (Res.) dated 25.07.2003 which states that; ***“The appointing authority, before appointing a person seeking appointment on the basis of reservation to OBCs should verify the veracity of the community certificate submitted by the candidate and also the fact that he/she does not fall in creamy layer on the crucial date. The crucial date for this purpose may be treated as the closing date for receipt of applications for the post except in cases where crucial date is fixed otherwise”.***

3. Therefore, the candidature of aforesaid 03 candidates for the post of Junior Assistant stands withdrawn/cancelled, due to non-submission of valid caste certificate on the closing date for receipt of application for the post.

4. No further communication shall be entertained in this regard.
