SUB: WITHDRAWAL OF INSPECTION COMMITTEE AND GRANT OF AFFILIATION TO SCHOOLS UNDER REGULAR CATEGORY I.E KV/JNV/GOVT SCHOOLS –REG.

As per clause 10.7 of Affiliation Bye-Laws, 2018, the Board has prescribed different procedure, format and mode of application for regular affiliation of schools mentioned in clause 2.2.6 of bye-laws. This include filling of online application for affiliation, inspection of schools and requirement to apply for extension of affiliation.

The schools falls under regular category i.e Kendriya Vidyalaya, Jawahar Navodaya Vidyalaya or Schools run by State Education Department are facing certain issue in procurement of various documents required for purpose of affiliation and requests for an early grant of affiliation as student of these schools has to step in class IX/XI. Also, the inspection of these schools is not currently feasible in view of current COVID-19 pandemic as schools are not functional. This may further delay the affiliation process of schools.

Therefore, keeping in view the current COVID-19 situation, the competent authority of the Board after due consideration has accorded approval to withdraw all committee constituted for inspection of subject schools and to grant affiliation to these schools with conditions. However, it shall be the responsibility of the competent authority of the school to immediately comply the conditions and shall keep the record which may be produced as and when required by the Board or appropriate Govt. Authority.
