## What is Commerce and Finance?

Commerce education in India is a general degree at the undergraduate level. Technically speaking, commerce does not relate to sourcing, manufacturing or production of processes. It is related to distribution of goods and services. Some of the main subjects of study include basics of accounting, economics, finance, business law, management, taxation etc. The courses build a foundation for the students to equip them with necessary knowledge and skills to function in the business world. An undergraduate degree in commerce can open up many career paths including accounts, management, finance, advertising, business law etc.

Finance is seen as a specific part of commerce. It involves management of money through activities such as investing, borrowing, lending and saving. In a finance related program, students learn financial theories and how they apply in the business world. Some of the main subjects of study may include accounting, economics, managerial economics, banking and insurance, finance, human resources, corporate law, investment banking, financial markets, taxation etc. Students learn mathematical concepts, statistics and analytical tools to solve problems and make decisions.



# **Career Prospects after Education in Commerce and Finance**

#### Accountant

An accountant is a professional who is responsible for managing, analysing, and reporting on financial information for individuals, businesses, or organizations. The role of an accountant involves maintaining financial records, preparing financial statements, ensuring compliance with financial regulations, and offering insights to help in decision-making processes.

#### Actuary

An actuary is a professional who uses mathematics, statistics, financial theory, and business knowledge to assess and manage risk. Actuaries primarily work in industries such as insurance, finance, pension planning, and healthcare, where they evaluate the likelihood of future events and help organizations make informed decisions related to risk management, pricing, and financial planning.

#### Advertising Representative

An advertising sales representative is responsible for getting advertising deals for their companies by selling packages to clients in media organizations. His/her job description entails selling available spaces and airtime to companies who have products and services to advertise in the organization's print or electronic medium.

#### Auditor

An auditor is a professional responsible for reviewing, analysing, and verifying the financial records and statements of individuals, organizations, or government entities to ensure accuracy, compliance with accounting standards, and adherence to relevant laws and regulations. Auditors play a key role in maintaining transparency and accountability in financial reporting, helping stakeholders trust that the financial information provided is accurate and reliable.

#### **BPO Executive**

A BPO Executive (Business Process Outsourcing Executive) is a professional responsible for managing and executing various business processes outsourced by companies to external service providers. BPO executives play a critical role in ensuring that business functions like customer service, data entry, technical support, finance, human resources, and other administrative tasks are efficiently handled by the outsourcing company.

#### **Budget Consultant**

Budget consultants, also called budget analysts, help individuals and organizations manage their finances by controlling spending and setting up budgets. They spend much of their time working by themselves, gathering and analyzing data, then preparing financial proposals.

#### **Business Analyst**

Analyst involved in the design or modification of business systems or IT systems. The analyst interacts with the business stakeholders and subject matter experts in order to



#### understand their problems and needs.

#### **Business Lawyer**

Business lawyers ensure that businesses comply with laws and regulations, protect their interests, and resolve legal disputes. Their expertise spans a wide range of areas, including contracts, intellectual property, mergers and acquisitions, taxation, employment law, and corporate governance.

#### **Chartered Accountant**

A Chartered Accountant is in charge of a company or organization's financial documentation. This position requires careful monitoring of each financial transaction with additional emphasis on how these transactions affect the general setting of an organization. Aside from financial documentation and its effects, chartered accountants are also in charge of taxation. They also provide financial reports and financial management services.

#### Commercial Banker

A Commercial Banker is an employee of a bank or financial institution who services the financial needs of clients. They try to maximize the profit of a bank while maintaining appropriate risk levels. Commercial banks accept deposits, make loans, safeguard assets, and work with many different types of clients, including the general public and businesses.

#### **Company Secretary**

A Company Secretary (CS) is a highly skilled professional who ensures that a company complies with legal, regulatory, and governance requirements. Acting as the link between the board of directors, shareholders, and regulatory bodies, the company secretary plays a crucial role in managing corporate governance, maintaining legal records, and advising on the legal implications of business decisions.

#### Cost and Works Accountant

Cost accountants are responsible for budgeting, cost management, performance evaluation and asset management within a company or organization. They typically collaborate as part of an executive team to create a financial plan for the organization.

#### Entrepreneur/Businessman

An entrepreneur is a person who sets up his own new line of business, with financial risks hoping for profits. He is the pioneer of individuals working under him and is responsible for coming up with new ideas and strategies for the benefit of the organization as a whole. You can be called an entrepreneur if you engage in any scalable startup, small business which grows towards the creation of an entire organization. An Entrepreneur and a Businessman are not the same. A businessman works in commerce, especially at the executive level. It is not important for this person to come up with innovative ideas or business line. It just takes an already running business line to get started with.



#### Finance Analyst

Financial Analysts researches macroeconomic and microeconomic conditions along with company fundamentals to make business, sector and industry recommendations. They often recommend a course of action, such as to buy or sell a company's stock based upon its overall current and predicted strength.

#### **Finance Consultant**

A Finance Consultant is a professional who provides expert financial advice and guidance to individuals, businesses, or organizations to help them manage their finances effectively and achieve their financial goals. Finance consultants analyse financial data, evaluate current financial strategies, and develop customized plans that improve financial performance, mitigate risks, and ensure long-term financial stability.

#### Finance Manager

Financial Managers are responsible for the financial health of an organization. They produce financial reports, direct investment activities, and develop strategies and plans for the long-term financial goals of their organization.

#### Finance Planner

A Financial Planner, also called a personal financial advisor, works with individuals and businesses to guide them in making budgetary, savings and investment decisions. They need good communication and interpersonal skills in addition to financial knowledge.

#### Financial Portfolio Manager

A portfolio manager is a person or group of people responsible for investing a mutual, exchange traded or closed-end fund's assets, implementing its investment strategy, and managing day-to-day portfolio trading. A portfolio manager is one of the most important factors to consider when looking at fund investing.

#### **HR** Executive

The HR manager needs to provide a title to the employees according to the departmental requirements. It is the duty of HR to design jobs that refer to the points which are mentioned in the job description. The HR manager needs to design the job according to the skills and potential of the employee.

#### **Insurance Consultant**

Insurance consultants perform a type of risk assessment. For example, an insurance consultant might visit a business, ask questions about typical practices, analyze workplace safety, identify relevant risks inherent in the industry and then offer targeted recommendations for what insurance policies the business should be carrying.

#### **Investment Analyst**



Investment Analysts provide stockbrokers, fund managers and stock market traders with financial information, advice and recommendations derived from global investment data.

#### **Investment Banker**

Investment Bankers are individuals who help companies, organizations and clients manage and grow their financial assets in capital markets by issuing debt or selling equity in the companies. They help companies make sound decisions when it comes to investing their assets with the motive of increasing the value of their investments. Other job duties include assisting clients with mergers and acquisitions (M&As), and advising them on unique investment opportunities such as derivatives.

#### Market Research Analyst

Market Research Analysts gather and analyze data on consumers and competitors. Market research analysts study market conditions to examine potential sales of a product or service. They help companies understand what products people want, who will buy them, and at what price.

#### Market Researcher

Market research analysts—sometimes called market researchers—help companies develop or maintain a competitive edge by finding and delivering data-backed insights into potential markets, competitors, and even customer behavior. They're an integral part of a company's overall marketing strategy and in-demand across multiple industries.

#### Marketing Manager

A Marketing Manager manages the marketing of a business or product. They can be responsible for several services or products, or be in charge of a single product. A Marketing Manager needs to have an outgoing, gregarious, and spontaneous nature.

#### Merchant Bankers

Merchant bank refers to a financial institution that conducts underwriting, loan services, financial advising, and fundraising services for large corporations and high-networth individuals. Merchant bankers are experts in international trade, which makes them specialists in dealing with multinational corporations. Unlike retail or commercial banks, merchant banks do not provide financial services to the general public.

#### Portfolio Manager

A Portfolio Manager is a person or group of people responsible for investing a mutual, exchange-traded or closed-end fund's assets, implementing its investment strategy and managing day-to-day portfolio trading.

#### Retail Banker



Retail bankers act in a customer service role, advising on and assisting with services such as setting up savings accounts, authorizing loans and moving money. Typical responsibilities of the job include: recruiting, training, supervising and appraising banking staff.

#### Retail Manager

A Retail Manager is a professional responsible for overseeing the daily operations of a retail store or chain of stores, ensuring that business objectives are met and customers have a positive shopping experience. They manage all aspects of retail management, from staff supervision and inventory control to sales strategy and customer service. Retail managers work to optimize the store's performance, driving sales growth while ensuring operational efficiency and high customer satisfaction.

#### **Retail Sales Executive**

Sales Executives are the key point of contact between an organization and its clients: answering queries, offering advice and introducing new products. Their work includes: organizing sales visits. Demonstrating and presenting products.

#### Stock Broker

A stockbroker is a professional trader who buys and sells shares on behalf of clients. The stockbroker may also be known as a registered representative or an investment advisor. Most stockbrokers work for a brokerage firm and handle transactions for a number of individual and institutional customers.

#### Tax Auditor

Tax Auditors use principles of accounting to evaluate financial records of individuals, companies, organizations or agencies and ensure they comply with federal, state and local tax laws.

#### Tax Consultant

Tax consultants often prepare tax returns for clients, or they provide information and advice to help clients fill out their own tax returns. They answer client questions, help them prepare for future tax situations, and analyse information to ensure compliance with government regulations.

Recruitment to the IA&AS is through the joint competitive examinations (the Union Public Service Commission) and through promotion from the subordinate cadre. Once recruited to the IA&AS, the directly recruited officers are trained mainly at the National Academy of Audit and Accounts, Shimla, Himachal Pradesh, India.

#### **Indian Civil Services**

One can join the prestigious 3 all India Civil Services including Indian Administrative Service (IAS), Indian Police Service (IPS) and Indian Forest Services (IFoS). One can also join any of the 16 Group 'A' Civil Services including Indian Foreign Service (IFS), Indian Audit and Accounts Service (IAAS), Indian Revenue Services (IRS) Etc. and other Central Group 'A' and Group 'B' Civil services.

#### management, and strategic decision-making.

#### Academic Program Director (in Finance or Commerce)

An Academic Program Director oversees the development, delivery, and improvement of finance or commerce-related programs at colleges or universities. They work closely with faculty members, students, and administrators to ensure that the programs align with current industry needs and educational standards.

#### Financial Analyst (in Academic Research Institutions)

Some academic institutions employ financial analysts to assist with research projects related to finance and economics. These roles may involve analyzing data for research purposes, forecasting financial trends, or evaluating the financial health of companies or industries.

#### **Industry Research Analyst**

Industry Research Analysts in finance and commerce focus on conducting research that benefits businesses or government organizations. They examine industry trends, market performance, financial health of companies, and economic indicators, often publishing reports used by organizations to make strategic decisions.
