

MEMORANDUM OF ASSOCIATION

The name of the Society is 'The Board of High School and Inter-mediate Education, Rajputana (including Ajmer-Merwara), Central India and Gwalior, Ajmer, hereinafter referred to as the 'Board'.

02. The registered office of the Board shall be situated in the Board's building, Ajmer.

03. The objects for which the Board is established are:-

i) To supervise and regulate High School and Intermediate Education and the Training of Teachers in Rajputana (including Ajmer-Merwara), Central India and Gwalior, and also to conduct Examinations in this area.

ii) To purchase, take on lease, accept as a gift or otherwise acquire any land or building, wherever situated in India, which may be necessary or convenient for the purpose of the Board.

iii) To construct or alter any building which may be necessary or convenient for the purpose of the Board.

iv) To sell, lease, exchange and otherwise transfer for consideration or by way of gift all or any portion of the properties assets and liabilities of the Board to any other society or person or persons.

v) For the purposes of the Board to raise and borrow money on bonds, mortgages, bills of exchange, promissory-notes or other obligations or securities, founded or based upon all or any of the properties, including the rights of Board or without any security and upon such terms as the Board shall think fit and to pay out of the funds of the Board all expenses of or incidental to the raising of money for the Board including brokerage and commission.

vi) For the purpose of the Board to draw and accept and make and to endorse, discount and negotiable bills of exchange, promissory notes and other negotiable instruments.

vii) To invest the monies of the Board upon such securities as may from time to time be determined and to transpose such investments.

viii) To make such grants as the Board may think it fit for the benefit of any employee of the Board.

ix) To do all such other things as may be incidental or conducive to the attainment of the above objects.
