Vide result Notice No. CBSE/Rectt.Cell/14(85)/DR/2020/2411 dated 22.03.2021, Sh. Kashmir Kumar (CBSE1465228) was shortlisted as provisionally eligible to the post of Under Secretary (earlier known Assistant Secretary), subject to fulfilment of other eligibility conditions stipulated in Recruitment Rules, Terms & Conditions of Advertisement No. CBSE/Rectt.Cell/Advt./FA/01/2019 dated 15.11.2019.

As per conditions in the Recruitment Rules of Under Secretary (earlier known Assistant Secretary) post, Sh. Kashmir Kumar was required to fulfil essential condition of working experience in Supervisory Capacity with experience in General Administration/ Establishment/ Accounts/ Examination in Government of India/ State Govt./ UT Administration or Central/State Autonomous/ Statutory Organizations/ PSUs/ Reputed Private Organizations and different working experience with minimum 05 years' regular service.

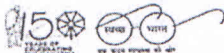
As per information provided by the parent department viz.; Office of the Commissioner of GST and Central Excise, Chennai South of Sh.
