The provisional selection of above candidates shall be further subject to genuineness of their document on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to photographs, signatures/handwriting etc. in the application form, admission certificate etc. The candidature of the candidate is liable to be cancelled by CBSE, in case, candidate is found not fulfilling all the eligibility conditions of the Recruitment Rules for the posts or for any other genuine reason. The decision of CBSE regarding eligibility of the candidate shall be final and binding on the candidate. The Competent Authority of CBSE shall issue the offer of appointment to the candidate after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to his Educational Qualification, age and other essential certificate.
