CLARIFICATION

All the Heads of CBSE Affiliated Schools

**SUB: CLARIFICATION REGARDING PROVISIONS MENTIONED IN CHAPTER 8 OF AFFILIATION BYE-LAWS RELATED TO "SCHOOL MANAGEMENT COMMITTEE".**

The Board is in receipt of certain queries from the stakeholders in the matter of constitution of School Management Committee as mentioned in chapter 8 of revamped Affiliation Bye-Laws, 2018.

In this connection, it is clarified that the school has to constitute School Management Committee (SMC) either as per provisions mentioned in Right to Education Act (RTE Act, 2009) or the regulations framed by the State/Appropriate Government.

Further, in the State/UT where RTE 2009 or State regulation is not in force, the school is required to follow the provisions as stipulated in Rule 8.2.2 of Affiliation Bye-Laws for constitution of SMC.

This is for information to all concerned stakeholders.
