M.R. Bharti Model Sr. Sec. School, K-53/15, Friends Colony, Mundka, West Delhi, Delhi-110041 was given Provisional affiliation with the Board for Secondary Level w.e.f. 01.04.2011 to 31.03.2014 & further upgraded to Senior Secondary Level w.e.f. 01.04.2014 to 31.03.2017. The affiliation is renewed from time to time and is affiliated till 31.03.2027 with affiliation number 2730681. As per conditions of affiliation, the school shall abide by the provisions of the Examinations and Affiliation Bye-Laws of the Board.

**AND WHEREAS**, all affiliated schools have already been informed through Board's notification dated 18.10.2018 to ensure compliance with the terms and condition mentioned in the Affiliation Bye-Laws, 2018 and also that the Board may conduct surprise inspection of school(s) any time to verify the status of compliance. Clause No. 12 of Affiliation Bye-Laws clearly lays down that any non-compliance of Examination and Affiliation Bye-Laws shall be considered as violation and action shall be taken as per the Rules in Chapter 12 of the Affiliation Bye-Laws, 2018.

**AND WHEREAS**, Chapter 14 – "General Rules", provides for the general rules which are required to be mandatorily followed

clause No. 14.1 states that, "Every school is bound to follow the Affiliation Bye Laws of the Board *mutatis mutandis*."

**AND WHEREAS**, clause No. 14.2 of the Affiliation Bye-Laws, 2018, stipulates that, "It is mandatory for every affiliated school to follow the Examination Bye-laws of the Board *mutatis mutandis*. Further, the clause 14.2.1 of the Affiliation Bye-Laws, 2018, provides that, "Every affiliated school shall present a list of number of students and their particulars in respect of Classes IX, X, XI & XII at the time of beginning of an academic session in the manner prescribed by the Board."

AND WHEREAS, the clause 14.2.2 of the Affiliation Bye-Laws, 2018, provides that, "No affiliated school shall present the candidates to the Board's examination who are not on its rolls." The clause 14.2.4 of the Affiliation Bye-Laws, 2018, provides that "No affiliated school shall present the candidates to the Board's examination who are on its roll but have not attended the school regularly or do not meet the requirement of minimum attendance for appearance in the Board's examination."

The clause 14.2.5 of the Affiliation Bye-Laws, 2018 further provides that, "Every affiliated school shall sponsor regularly its bona-fide and eligible students in Boards Class X and Class XII examinations from the year mentioned while granting affiliation/ upgradation regularly without break or inform with reasons thereof in writing well in time about the non-sponsoring of the candidates".

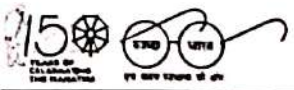
AND WHEREAS, Chapter 11 of the Affiliation Bye-Laws provides that the Board may conduct the inspection of the Schools including the surprise inspection to ascertain and ensure that schools are following the provisions of the Examination Bye-Laws, Affiliation Bye-Laws and any other instructions issued by the Board from time to time. Clause 11.4 of CBSE Affiliation Bye Laws, 2018 related to the Surprise Inspection of the schools states that, "The Board may any time get an affiliated school inspected by a committee of one or more members without giving any notice to the school." This activity of surprise inspection can be carried out any time to ensure the due compliance of Statutory Provisions, Bye-Laws of the Board and compliance of any legal mandate and all the schools are bound to offer themselves for such inspection as and when directed.

AND THEREFORE, on the basis of the enabling provisions contained in clause 11.4 of the Affiliation Bye-Laws, 2018, the Board conducted Surprise Inspection of the school M.R. BHARTI MODEL SR. SEC. SCHOOL, K-53/15, FRIENDS COLONY, MUNDKA, WEST DELHI, DELHI-110041 on 03.09.2024 through a two member Inspection Committee.

In order to follow the course of natural justice and to maintain transparency, the copy of inspection report was provided to the school alongwith the Show Cause Notice.

A. On the basis of the report submitted by the Inspection Committee and analysing the data available with the Board, following *inter-alia* violations were noticed:-

1. As per the records available with the Board, total 318 students were registered in Class XI in the school for the academic session 2023-24. By the natural progression, these students would have been promoted to class XII in the academic session 2024-25. As per the report of the inspection committee, on the day of inspection only 26 students in class XII were found present in the school and only 271 were enrolled in the attendance register. It clearly reflects that the school is sponsoring dummy/non attending students in its school which is a severe violation of clause 14.2 of Affiliation Bye Laws of the Board.
2. En masse admission in class XI and XII on a single date was noticed. No student of the science stream was present. Only 26 students against the 271 enrolled students were present. No evidence of conducting practical was noticed. The School has enrolled non attended dummy students, which is a violation of clause 14.2 of Affiliation Bye-Laws-2018.
3. It is further reported by the Committee that some of the students of class XI & XII were found from different outside cities/states i.e. Meerut, Agra, Mahendergarh, Rajasthan, which is a violation of clause 14.2 of Affiliation Bye-Laws-2018.
4. The students of class XI were given admissions in bulk from single schools after passing class X<sup>th</sup> exam i.e. Euro International School, R.P.S School and Yaduvanshi Shiksha Niketan, which is a violation of clause 14.2 of Affiliation Bye-Laws-2018.
5. All the classrooms of the school are undersized with the dimension of 20'x22'=440 sq.ft., which is a violation of clause 4.1 of Affiliation Bye-Laws-2018.
6. The school does not have Maths Lab which is a violation of clause 4.5.
7. The Composite Science Lab has not been established by the school, which is a violation of clause 4.2 & Circular 11/2022 of Affiliation Bye-Laws-2018.

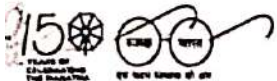

8. As per the report of the inspection committee, Science Specific Laboratories were not functional and the adequate apparatus were not available, which is a violation of clause 4.2 & Circular No. 11/2022 of Affiliation Bye-Laws-2018.
9. The Library is undersized with the dimension of 44'x22'=968 sq ft whereas as per clause no.4.3 of affiliation bye laws, the size of the Library should be 1200 sq ft. , which is a violation of clause 4.3.1 of Affiliation Bye-Laws-2018.
10. Sign. Board of R.M. College of Nursing and R.M. College of Education have been found inside and outside of the school campus and students of these institutions were seen inside the campus. The students with the Uniform of these institutions could be seen in the campus, which is a violation of clause 14.10 of Affiliation Bye-Laws-2018.
11. Admission & Withdrawal Register has not been filled properly/completely, which is a violation of clause 14.19(a) of Affiliation Bye-Laws-2018. Further, the inspection committee could not inspect all admission forms, as they were not shown to the committee.
12. As per records provided to the inspection committee, total 45 teachers have been appointed by the school which is not adequate to maintain the section and teacher ratio i.e. 1:1.5, which is a violation of clause 5.4 of Affiliation Bye-Laws-2018. Further, the committee could not meet with adequate science faculty.
13. Further, the Counsellor and Wellness Teacher has not been appointed by the school, which is a violation of clause 2.4.12 of Affiliation Bye-Laws-2018.
14. No. of appointed Physical Education Teacher/PTI is inadequate, which is a violation of clause 2.4.10 of Affiliation Bye-Laws-2018.
15. As per the inspection committee, safety provision are not upto the mark in the school which is a violation of clause 4.7.7.
16. Service Rules are not available, which is a violation of clause 5.3 of Affiliation Bye-Laws-2018.
17. Teachers of the school have not attended the mandatory training programmes (CBP), which is a violation of clause 16.1.1 of Affiliation Bye-Laws-2018.

- B. In order to provide the School a chance to submit its explanation/ clarification, a Show Cause Notice dated 13.09.2024 was served to the School.
- C. The School had submitted its reply vide letter dated 10.10.2024 wherein the School had submitted its explanation on the violations committed by the school:
- D. The school vide its reply dated 10.10.2024 has inter-alia made, the following submissions on the Show Cause Notice dated 13.09.2024:
- I. The school in its reply denied that there are any dummy or non- attending students enrolled in school. The student strength of school of classes XI and XII for sessions 2023-24 & 2024-25 is as follows:-

- II. In proof, the copy of complete admission withdrawal register (incorporating the admission details of session 2023-24 & 2024-25) along with copies of admission forms (on a sample basis), school leaving certificates/ transfer certificates, and attendance register for few months are enclosed. Regarding absenteeism of students on day of inspection, the school has submitted that the absenteeism among students on the day of inspection can be attributed to two facts, one being waterlogging near the school which made it inaccessible for students, and second being the fact that senior students often remain absent when examinations are approaching. The school has further submitted that in the week preceding date of inspection, the city of Delhi experienced severe and persistent rainfall, leading to extensive waterlogging in various parts of the city, including the area surrounding the school. This situation was widely reported in daily newspapers. In proof, copy of the newspaper reports are enclosed for reference. As a result of the waterlogging, many of the students were unable to attend school on the day of the inspection due to access issues, which led to a significant drop in

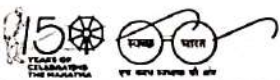
attendance. Further to waterlogging, it is submitted that senior students often remain absent when examinations are approaching. These students were fully aware of the Mid Term Examination schedule, and many had taken leave to prepare for their respective subjects. In addition to coming to school regularly, a considerable number of students are enrolled in private coaching institutes as well for competitive exams such as JEE, NEET, and other advanced courses. These institutes provide specialized guidance, often focusing on areas beyond the school curriculum, to help students achieve their career aspirations. As a result, students tend to prioritize these coaching sessions over regular school attendance, especially as their exams draw near. Therefore, the school has asserted that the school is not sponsoring any dummy or non-attending students, as these students are simply striving to maintain a challenging balance between regular school education and their preparation for higher education.

- III. The school has further mentioned that students from outside Delhi frequently seek admission to CBSE-affiliated schools within the National Capital Territory (NCT), owing to the superior quality of education offered in the region compared to their native cities or states. Following this trend, the school also enrolls students from outside the Delhi NCR, many of whom currently reside in Delhi while attending the school, drawn by the high standards of education we provide. In proof, copies of admission forms of a few such students are enclosed for your reference. Furthermore, upon reviewing Clause 14.2 of the CBSE Affiliation Bye-laws, it is evident that there is no prohibition against the enrolment of students from outside Delhi seeking regular education in schools operating within the National Capital Territory (NCT). In light of this, we respectfully request that the school be considered compliant with the applicable regulations, and the noted deficiency be set aside. In continuation of the above submissions, the school respectfully states that students frequently seek admission to CBSE-affiliated schools within the National Capital Territory (NCT) due to the superior quality of education available in this region as compared to their home cities or states. In line with this trend, the school regularly receives a significant number of admissions, particularly from certain schools where the strong academic track record is well-known. Therefore, the influx of admissions from a few specific schools should not be viewed negatively but

rather as a testament to the goodwill and reputation the school has earned through its consistent academic excellence. As evidence of the proper admission of these students, the school respectfully encloses the admission forms of a few such students for reference and consideration.

- IV. The school has further submitted that the school maintains the size of classrooms and enrolment of students per section as per the rules and norms prescribed by the recognizing authority, being Directorate of Education, Delhi, for the schools running in New Delhi. In proof, the details of utilization of school accommodation along with copy of site plan is enclosed. The school has further stated that, apart from holding CBSE affiliation for conducting board examinations for Classes X and XII, the school has also received recognition from the Directorate of Education (DOE), Delhi, for Classes Preschool through XII. This recognition followed a thorough evaluation of the infrastructural requirements, safety standards, and facilities necessary for the holistic development of students and regular inspections from DOE Delhi to ensure regular attendance and functioning of school. The school was last inspected by DOE Delhi on August and in pursuance to the said inspection, no adverse observation was given by the department to the school. In proof, supporting documents are enclosed. Given that the DOE Delhi has deemed the infrastructure and overall school running as adequate and compliant with its standards, we respectfully request that the school be seen as compliant with the norms required for senior secondary education and the all-round development of students, as verified by the competent government authority.
- V. The photographic evidence of Mathematics lab with latest list of available equipment is hereby enclosed for consideration.
- VI. The school has further submitted that the school is recognized up to the Senior Secondary Level across all streams and is equipped with well- maintained laboratories for Physics, Chemistry, and Biology. These specialized laboratories cater to the advanced needs of senior secondary science students and include all necessary facilities and equipment to deliver quality practical instruction to the students of lower classes as well. Therefore, the presence of a composite science laboratory is effectively met through these adequately equipped individual laboratories. In proof,

- VII. In its reply the school has mentioned that it has a fully functional library having a stock of over 7000+ textbooks, newspapers, and periodicals. The library is spread over an area of 7040 sq. ft. with adequate seating arrangement which is in accordance to the rules and norms as prescribed by the school's recognizing authority, being DOE Delhi. In view of the same, it is requested that the school's library infrastructure may please be seen as sufficient to cater to the quality learning environment of its students. The school further submitted that the parent society of the school, Mangu Ram Education And Social Welfare Society, is duly registered under the Societies Registration Act, 1860. The primary objective of the society is to impart quality education. It is strictly a charitable organization, and no commercial activities are undertaken by the society. In alignment with its aims, the society operates MR Bharti Public School and MR Bharti College of Education. It is clarified that the school and the college operate on adjoining lands. The school is located at [K 53/15, FRIENDS COLONY, MUNDKA DELHI 110041.], and the college is situated on the adjoining plot, bearing the address [53/6, MUNDKA DELHI 110041). Additionally, another institution, MR Bharti College of Nursing, is also operated nearby, offering nursing education to interested students which is also run by a charitable trust. Despite the proximity of the school and the colleges, they each have independent campuses and separate ingress/egress points. This ensures well-managed, seamless education for students across all institutions. As evidence, copies of the land documents where the school and colleges are located, along with recognition letters from their respective competent authorities, are enclosed for reference. Due to the close proximity of these institutions, many students have siblings in the neighbouring institutions, or their parents may be employed as staff members in either the school or colleges. This may explain occasional sightings of college students in the vicinity of the school. Upon reviewing Clause 14.2 of the CBSE Affiliation Bye- laws, it is evident that the school building shall not be used for any commercial activity and should be utilized solely for the promotion of education and skill development, including vocational education. Given that no commercial activities are being conducted on any of the said lands and that these premises are exclusively

- IX. The school has appointed PRERNA as Counsellor & Wellness Teacher in school. In proof, copy of the appointment letter and joining report is enclosed. The school has appointed SANDEEP as Physical Education Teacher in school. In proof, copies of the appointment letter and joining report are enclosed.
- X. The school has submitted that the school is taking all steps to ensure student safety as per the orders/guidelines of the DOE, being the school's recognizing authority, and judicial pronouncements with respect to safety of students as per DOE circular dated 07.11.2017. Undertaking to the same effect is enclosed.
- XI. The school has further submitted that the school, having been recognized by the Directorate of Education Delhi, appoints all its staff as per the posts and rules so prescribed by the DOE, Delhi, In proof, copy of the recruitment rules for schools, so recognized by DOE Delhi, are publicly available on [www.edudel.nic.in](http://www.edudel.nic.in) for reference and consideration.

XII. The school has made commitment that its eligible staff will attend the mandatory training and capacity building programs (CBP) as prescribed by CBSE during the ongoing 2024-25 session. An undertaking to this effect is enclosed for consideration.

**E. The analysis of the submissions made by the School in its reply and the violations found:-**

1) In its reply the school has denied that there are any dummy or non- attending students enrolled in school. The school has stated that the present strength of students in class XII of their school is 309 students in 2024-25. Whereas the surprise inspection committee had reported that there were only 26 students present on the day of inspection i.e. 03.09.2024 out of total 309 students as per LoC. This huge gap between numbers of students present in class XII against the total registered students establishes that the school is sponsoring dummy/ non-attending students. This establishes the violation of Clause no.14.2 of Affiliation Bye-Laws of the Board. Further, the school's submission that there was low attendance due to heavy rainfall in the area, in support of which the school has attached news paper cuttings is also un-satisfactory and not-tenable because if there have been heavy rainfall then the attendance especially in the lower classes should have been effected more than the attendance of higher classes whereas as per inspection committee's report, in Bal Vatika-I 22 students out of 29 students were present, in Bal Vatika-II 8 students out of 10 students were present, in Bal Vatika-III 40 out of 49 were present, in class-I 57 students out of 67 students were present, class-II 72 students out of 81 were present. The similar trend is observed upto Class XI. However, suddenly, there was a sharp decline in present students in class XII i.e. only 26 students of out of total registered 309 students in LOC 2024-25 were present on the day of surprise inspection which clearly establishes the fact that the school is trying to mislead by giving wrong submissions. There is no logical submission that the younger students in primary and upper primary classes were able to commute to school but, the senior students of class XII were unable to commute to the school. The submission of the school is also factually incorrect as the inspection Committee had smoothly conducted the inspection and had not reported any water logging in the area on the day of inspection. Moreover, the photographs submitted by the school in its submission about water logging and heavy rain

are geo tagged in first week of October, which clearly makes it evident that the school is presenting the photographs taken after one month of the day of inspection. Further the videography carried out by the inspection team also shown no rain and water logging. The school is misleading the Board to hide its irregularities and violation of admission in classes XI and XII. The school itself has further stated that "a considerable number of students are enrolled in private coaching institutes as well for competitive exams such as JEE, NEET, and other advanced courses....., students tend to prioritize these coaching sessions over regular school attendance," Even after knowing this fact that the students are not regularly attending classes, the school is presenting these students to Board's examination which is the violation of **clause no.14.2.4 of Affiliation Bye Laws of the Board** which stipulates "no affiliated school shall present the candidates to the Board's examination who are on its roll but have not attended the school regularly or do not meet the requirement of minimum attendance for appearance in the Board's examination". If the students were not attending classes, then the school could have stopped their sponsorship of these students for the Board's examinations, however the school has not done so which is an intentional violation of the **Clause 14.2.4 and 14.2.5 of Affiliation Bye-Laws of the Board**. In additional to above, **Clause 14.7 of Affiliation Bye Laws of the Board** stipulates "The school shall take steps to see that physical & health education, life skills education, digital education for students and teachers, experiential learning, value education with particular emphasis on National Integration is imparted to students through teaching of various subjects and activities in the school curriculum." and **clause 2.4.8 QUALITY OF EDUCATION** stipulates "The school must be quality driven and must strive for excellence in all aspect of its activities. It must follow the directions issued by the Board from time to time regarding introduction of innovative practices in areas of curriculum, pedagogy and evaluation." If the school does not maintain regular attendance of students, quality education which includes physical & health education, life skills education, digital education would not be possible under any circumstance. Thus, the school has violated the **clauses No. 14.2.4, 14.2.5, 14.7 and 2.4.8 of Affiliation Bye-Laws of the Board**.

The school has registered 276 students in science stream, however, in the SCN point No.2, it was communicated that no students of science stream was present. The school

has not submitted any explanation to this point except that "*students tend to prioritize these coaching sessions over regular school attendance especially as their exam draw near*". The school has also not submitted any explanation on the point "*no evidence of conducting practical was noticed*". Therefore, it is assumed that the school has nothing to represent against these two points and is in turn accepting them which again substantiate the point of sponsoring dummy/non attending students.

Further as per Clause 6.5 of Examination Bye-Laws of the Board "...the candidate shall complete the required percentage of attendance (75%) for Class IX, X, XI & XII as per Examination Bye Laws of the Board to make him/ her eligible for the examinations. In such cases where the admission by the candidate could not be taken in a higher class by the stipulated date because of the late declaration of result by the Board such permission would not be required, provided the candidate applied for admission within a fortnight of the declaration of the result."

**AND Clause 13.1(i)** "...Candidates taking up a subject(s) involving practicals shall also be required to have put in at least 75% of the total attendance for practical work in the subject in the laboratory. Heads of Institutions shall not allow a candidate who has offered subject(s) involving practicals to take the practical examination(s) unless the candidate fulfils the attendance requirements as given in this Rule.

**AND Clause 13.2(i)** "No student from a School affiliated to the Board shall be eligible to take the examination unless he has completed 75% of attendances counted from the opening of class X/XII upto the first of the month preceding the month in which the examination commences in the subjects of internal assessment." Therefore, the school has blatantly violated the **Clauses 6.5, 13.1 (i) and 13.2 (i) of the Examination Bye-Laws as well.**

- 2) The finding of the committee that the school has admitted most of the students from the outside locations such as Mahendergarh , Rewai, uttarakhand ,Gurugram goes to show that the school has admitted the students from far off locations whereas as detailed and proven in point number one above, majority of the students of senior classes are non-attending or were absent. As per the admission forms submitted by the school, this fact

has been made evident as most of the addresses and the documents of the students are from far off areas. This is further supported by the fact that the school is not residential, therefore how these students commute daily to reach school is also not explained. This further the findings of the committee as detailed in point number 1 above.

- 3) Inspection committee had reported the classrooms are undersized by mentioning their dimension 20'x22' (440 sq ft) against the minimum requirement of 500 sq ft. as per affiliation bye laws of the Board. In reply to this objection, the School has submitted that "The school maintains the size of classrooms and enrolment of students per section as per the rules and norms prescribed by the recognizing authority, being Directorate of Education, Delhi, for the schools running in New Delhi..... The school was last inspected by DOE Delhi on August and in pursuance to the said inspection, no adverse observation was given by the department to the school". In this regard, it is informed that **Clause 19 of Chapter VI of the Delhi School Education Act, 1973** stipulates that "For the purpose of any public examination every recognized higher secondary school shall be affiliated to one or more of the Boards or Council conducting such examination and **shall fulfil the conditions specified by the Board or Council in this behalf**", hence the schools affiliated with the Board are bound/compelled to follow the Affiliation Bye Laws of the Board in respect of the infrastructure *inter-alia* other requirement as prescribed by the Board. Therefore, it is an established fact that the school has violated infrastructure norms of the Board. Further, the classrooms are undersized to the extent that the school is not even providing at least 1 sq. mtr. floor area to a student. The size of classrooms and class/section wise enrolment of students per section clearly establishes the violation of **clause 4.1 of Affiliation Bye Laws of the Board** which stipulates that minimum floor space should be at least 1 sq. mtr. per student.

- 4) After physical inspection of the school, the inspection committee had reported that Science Specific Laboratories were not functional and the adequate apparatus were not available. In its reply, the school has submitted that it is "equipped with well-maintained laboratories for Physics, Chemistry, and Biology. These specialized laboratories cater to the advanced needs of senior secondary science students and include all necessary facilities and equipment to deliver quality practical instruction to the students of lower

classes as well". The school has not furnished even a single evidence in support to its statement. The committee who had physical inspected the school had found that the Science Specific Laboratories were non-functional and were not having adequate apparatus, which establishes clear violation of **clause 4.2 & Circular No. 11/2022 of Affiliation Bye-Laws of the Board.**

- 5) As per Affiliation Bye Laws of the Board, minimum size Library should be **14 m. x 8 m. (i.e 1200 sq ft approx)**. The inspection committee in its report has informed that the Library of the school is undersized. In its reply to the SCN dated 13.09.2024 the school has submitted that "*The library is spread over an area of 7040 sq. ft.*" whereas as per the building map of the school (attached with its reply), the dimension of its Library is 19'10"x 36'11"=732 sq ft. which is itself contradictory to the statement of the school which clearly establishes that the school is not adhering to infrastructural norms which is a violation of **clause 4.3 of Affiliation Bye-Laws of the Board.**
- 6) At the time of physical surprise Inspection of the school, Committee had found signage of (i) M.R. Bharti College of Nursing and (ii) M.R. Bharti College of Education inside and outside of the campus of the school. Further, the students of these institutions in uniform were also seen inside the campus. In its reply, the school has clarified that these colleges are being run on separate land but the school has not furnished any documentary evidence in support to its statement by enclosing copy of any land document with its reply. The school has also not been able to justify as to why the signage of other colleges/institutes i.e. M.R. Bharti College of Nursing and (ii) M.R. Bharti College of Education were there in the school, and as to why the students of other colleges or institutes were there in the school campus in their college uniform. This clearly establishes that three different institutes/Colleges are being run in the same campus i.e. M.R. Bharti Model Sr. Sec. School, M.R. Bharti College of Nursing and M.R. Bharti College of Education which is a violation of clause 14.10 of Affiliation Bye-Laws of the Board. The presence of students / personnel of other institutions in the school's premises heightens the possibility of compromise on the safety and security of the students.

Therefore, the school has violated the safety clause 4.7.6 of Affiliation Bye Laws of the Board.

- 7) Although the school has submitted a copy of the AWR. However, the same was incomplete/not properly filled at the time of inspection, therefore, the submission of copy of AWR alongwith its reply establishes the fact that it was updated later on. Therefore, its authenticity cannot be ascertained which is violation of clause 14.19 (a).
- 8) As per the inspection Committee report, there were only 45 teachers (PGTs/TGTs/ PRTs/NTTs) against total 35 sections (including Bal Vatika) in the school. In its reply the school has submitted that it is maintaining section teacher ratio of 1:1.5 but in support to its claim, the school has not enclosed any document evidence viz. detailed list of teachers with their designation, bank statement of school's account showing salaries transfer in respective bank accounts of PGTs/TGTs/ PRTs/NTTs, proper attendance record of teachers, their appointment letter, their joining report, service records, EPF Challan of monthly contribution etc. and the detailed list of the teachers has also not been submitted alongwith its reply which uphold the statement of the surprise inspection committee that the school is not maintaining section teacher ratio as per the norms of the Board and there are not more than 45 teachers (PGTs/TGTs/ PRTs/NTTs) against 35 sections in the school which establishes the violation of **clause 5.4 of affiliation bye-laws of the Board.**
- 9) After the physical inspection of the school, the inspection committee had reported that "safety provisions are not upto the mark in the school". In its reply, the school has mentioned that it is taking all steps to ensure student safety as per the orders/guidelines of the DOE but in support to its claim the school has not furnished any document viz copy of Fire safety certificate, Water and Sanitary Condition Certificate, water test report etc which establishes violation of clause 4.7.7.
- 10) As per the inspection committee report Service Rules were not available in the school. The school has not submitted its clarification in this regard which establishes the violation of clause 5.3 of Affiliation Bye-Laws of the Board.

11) The School has submitted an undertaking that all the eligible staff members of our school will attend the mandatory training and capacity building programs as prescribed by the CBSE during the ongoing academic session 2024-25, however this also proves that till now the school's teachers were not getting trained which is a clear violation of **clause 16.1.1 of the affiliation Bye-Laws of the Board.**

Thus, the following violations are established beyond doubt:-

1. The school is indulged in sponsoring dummy/non attending students.
2. Three different institutes/Colleges are being run in the same campus i.e. M.R. Bharti Model Sr. Sec. School, M.R. Bharti College of Nursing and M.R. Bharti College of Education. The students of these institutions have access to this school's campus which may compromise the safety of students.
3. The school is not adhering to the norms framed for the safety of the students.
4. The school's classrooms are undersized to the extent that the school is not even providing at least 1 sq. mtr. floor area to a student.
5. The Library of the school is undersized.
6. The Science Specific Laboratories are non-functional with inadequate apparatus.
7. The school is not maintaining section teachers' ratio as per norms of the Board.
8. The school has not framed Service Rules for its employees and the school is not getting it's teachers trained.

Accordingly, it is for consideration as to which of the penalties mentioned in the clause 12.1 of the Affiliation Bye Laws be imposed on the school. Since the violation observed are clearly manifesting wilful non-observance of the Affiliation Bye Laws to the extent of deliberately sponsoring non bonafide students and manipulation of records, therefore it can only be concluded that the school is liable for the severest of the penalty as can be imposed viz. withdrawal of affiliation. Hence, as per the approval of the competent authority, the following orders are issued:-

1. The Provisional Affiliation granted to the school upto Senior Secondary Level be withdrawn with immediate effect.
2. Student in class X and XII are permitted to appear from the same school for session 2024-25.

3. However, the students who are presently in class IX and XI shall be shifted to nearby school by Regional Officer, Delhi (West). The school shall not take any new admissions or promote the students of lower classes in IX and XI by natural progression, hereafter
4. The school may seek restoration of affiliation upto secondary level after lapse of one academic year i.e. from 2026-27 after ameliorating the deficiencies pointed out with regard to running upto secondary level.
5. The school may seek restoration of affiliation upto senior secondary level only at least after 02 academic years of restoration upto secondary level, if so sought and granted.
