OFFICE ORDER

In reference to budgetary provisions, the Competent Authority has appointed the following officers as DDOs/Second Signatory with given instructions:

- 1. All CoEs shall maintain separate budget to meet its expenses. The Budgetary/ fund requirment of the Centres shall be released through Headquarters. For this, all CoEs are requested to adhere with the direct ions given in Circular No.CBSE/ AC&BW/ACCOUNTS/2016-17/Circular/241 dated 16.08.2017.
- 2. All CoEs (other than existing CoE(s) having bank account) will open separate bank account in the name of "Secretary, CBSE" in the nationalised bank preferably in Syndicate Bank.
- 3. As per instructions given vide cirucular No.AC&BW/Accounts/NC/2016/174-204 dated 13.01.2016, the concerned RO will transfer a sum of Rs.10 lakh initially on imprest basis system to recently established CoEs.
- 4. Concerned RO shall disburse the salary and allowances to the staff of CoE till further orders.
- 5. All CoEs shall maintain separate books of accounts. All CoEs shall submit the monthly accounts along with allied schedule to Headquarter latest by 10th of each following month.
