Consequent upon the decision of the Central Government to extend the revised pay scales as per the Pay Matrix, as contained in Part-A of the Schedule of the Central Civil Services (Revised Pay) Rules 2016 as well as the principle of pay fixation as contained in the said rules, to the Autonomous Organisations, the Chairman, CBSE has approved the adoption of the CCS (RP) Rules, 2016 as notified on 25.07.2016 by the Ministry of Finance, Department of Expenditure vide G.S.R. 721 (E) in CBSE in accordance to the stipulations contained in Department of Expenditure, Ministry of Finance OM No. F.No.1/1/2016-E.III(A) dated 13.01.2017.

2. All the Regional Offices and Headquarters (in respect of offices in Delhi/NCR) is required to constitute a suitable 'Implementation Committee' comprising of one officer each from Administration, Account and DDO to implement the revised pay scales as per the Pay Matrix contained in Part-A of the Schedule of the CCS (RP) Rules 2016.
3. The revised pay scales as per the Pay Matrix shall be effective from 01.01.2016 and the arrears of pay shall be paid as per the provisions under Rule 14 of CCS (RP) Rules 2016.
4. As the Central Government has not taken any decision so far in regard to various allowances, the existing allowances shall continue to be admissible as per the existing terms and conditions irrespective of the adoption of revised pay scales.
5. One day 'Sensitisation & Briefing session' on the implementation of CCS (RP) Rules 2016 shall be held at CBSE Headquarters on 02.02.2017. All the members of the 'Implementation Committee' of the Regional Offices and Headquarters are required to attend this programme.
