MINUTES OF THE GOVERNING BODY MEETING HELD ON 15TH DECEMBER, 2017

The Chairperson, CBSE welcomed all the members of the Governing Body present in the meeting. The list of participants in the Governing Body is at **Annexure – 1**.

- 2. Chairperson, CBSE in her inaugural speech informed and discussed the following:
 - a) As on date, CBSE has 20,140 schools affiliated to it. Achieving this number is a major milestone for the Board. At the time of starting of CBSE in 1929 there were only 29 schools affiliated to the Board. In the last 4-5 months more than 1100 schools were affiliated and approximately 3000 cases lying pending for a long time in Affiliation Unit were disposed off.
 - b) In March-April 2018, the number of students appearing in the Board exams would be about 30 lakhs for class X & XII Examinations. The Class X board examination will be held for the first time after a gap of about seven years.
 - c) With such huge numbers appearing for the Board exams, the Board is trying to ensure that its evaluation process is more robust.
 - d) CBSE, besides doing Affiliation and conduct of Board examinations for Class X and XII, also holds several other competitive examinations like JEE, NEET, UGC-Net, KVS recruitment, JNVST, etc. Through a cabinet decision, the National Testing Agency (NTA) has been created which will take over most of the competitive examinations from CBSE in a phased manner. However, until then CBSE will be holding the JEE in the month of April and NEET in the month of May in 2018.
 - e) It was also informed that CBSE has conducted UGC-NET in the month of November 2017 with 9.5 lakhs registered candidates. The result of UGC-NET November 2017 for more than 7.5 lakhs candidates who appeared in the exam will be declared in less than two months.
- 3. Chairperson, CBSE shared glimpses of the new initiatives taken by the Board:
 - a) Though the processing of applications for affiliation to CBSE is both offline and online, the Board is now developing software for making the processing of affiliation application 100% online from 2019. Even approval of the Chairperson would be accorded online.
 - b) In CBSE schools, Physical Education is being offered as a subject with different methodologies and pedagogies. CBSE has setup an expert committee to suggest a holistic Physical and Health Education Curriculum. This committee is also holding consultation with Ministry of Sports, Ministry of Home Affairs, etc.

- c) Considering inclusive education as an important area of intervention, CBSE has setup an expert committee for Children with Special Needs (CWSN). After finalizing the Board's policy based on these recommendations, CBSE will implement the same.
- d) Curriculum for classes IX to XII is slightly unbalanced in terms of distribution of content within the classes, leading to the children feeling the burden of the curriculum in particular classes. Therefore, CBSE is trying to balance the curriculum, and wherever necessary, will remove the redundant part of the curriculum.
- e) While discussing the matter of re-evaluation, Chairperson informed that the Board is taking up reforms to come up with an error free robust evaluation system.
- f) CBSE will adopt / implement the e-office system in the coming financial year with the help of Ministry of IT, Govt. of India.
- g) A transparent transfer policy is being initiated in CBSE. An agenda for approval of the same has been placed. It was also informed that after receipt of applications / requests regarding recruitment/promotion/cadre review from the CBSE staff/Association, a cadre review committee is also being taken up in a phased manner.
- h) In the interest of increased efficiency and effectiveness and also for costeffectiveness, CBSE is planning to restructure its existing Regional Offices & Centre of Excellence (COEs) and will look into opening new ROs/COEs as per need and requirement, keeping in view the increase in the number of candidates sponsored by its affiliated schools. COEs in various cities will be co-located with RO offices, in the interest of economic viability and accessibility for schools.
- i) CBSE is also planning to initiate recruitment processes for filling its various vacant posts.
- j) Henceforth, the Board will not be taking up printing activities of its publications. As per the directions of MHRD, the printing of CBSE books will be done by NCERT. Wherever there are curriculum gaps in the subjects including vocational subjects where NCERT books are not available, the Board will develop e-content and will make it available free on Board's website.
- k) CBSE is coming up with School Quality Assurance and Assessment Framework (SQAAF) for benchmarking schools and encouraging them to excel.
- CBSE is also planning to re-structure its CBSE teacher's awards system by making it an online application system, wherein the sifting and selection will be based on objective criteria and evidencing.
- m) CBSE is also exploring the proposal of having two level of mathematics i.e., standard and higher level at secondary and sr. secondary stage.
