CIRCULAR

In continuation to Notification No. CBSE/Rectt. Cell/ 1(1)/2018/11186-11285 dated 03.07.2018 wherein the post of Junior Observer, Observer, Record Keeper and Project Associate (Technical) were merged in Accounts Cadre and further as per the recommendations of the Committee constituted for deciding the inter-seniority/combined seniority of officials working on these posts, the same has been prepared subsequent to its approval by the Competent Authority of the Board.
