The minutes of meeting of the Governing Body of the Board held on 22.08.2022 at 10:30 AM at CBSE Headquarters, 2nd floor, Conference Room, Preet Vihar, New Delhi 110092 were approved by the Controlling Authority of the Board i.e. Secretary (SE&L), Ministry of Education, Govt. of India on 09.09.2022 and the same were accordingly circulated to all concerned for information and necessary action.

The Controlling Authority while according approval to the minutes has directed to reconsider and sought further justification in respect of following two agendas of Finance Committee Meeting vide her remarks dated 09.09.2022:

1. Exposure Visits for the Principal of CBSE Affiliated Schools (Finance Committee-Agenda Item VI (2))

The National Education Policy 2020 envisages that by 2025 at least 50% of learners through the school and higher education system shall have exposure to vocational education, for which a clear action plan with targets and timelines are to be developed.

Accordingly, the Board is planning to institutionalize a mechanism through which School leaders will be given exposure through various institution of eminence in India so that they can collaborate with such institute in future to integrate vocational education into mainstream education also utilize the infrastructure in time shift manner (or in vacation) created by the Government.

Exposure visits shall be arranged in 25 or more institutes of prominence like IITs, IIMs, IISC, Bengaluru, IISER, IIITs, NITs, Agricultural Universities under ICAR, NIDs, NIFTs, Central Tool Room and Training Centres, IHM, Indian Instt of Travel and Tourism, National Law University, ISRO, CDAC, Skill Universities, VIT Vellore, BITS Pilani, BIT Mesra, ISM, University of Hyderabad, University of Madras, Banaras Hindu University, University of Delhi, Jadavpur University, KIIT, Bhubaneswar, NITTIE, Mumbai, National Institute of Advanced Studies Bangalore, IMI Chennai, National Stock Exchange, NIFM, IIMC, Christ University, Azim Premji University and some other premier private Universities/Institutes, India Research Centre of IBM, Intel, Microsoft etc.

Initially, government schools like (KVs, JNVs, EMRS etc.) shall be involved followed by private schools. The Principals/representatives of private schools will make the travel arrangements themselves.

The expected financial implication would be approx. Rs. 11.50 crore.

2. Opening/ Establishing of New Regional Office at Visakhapatnam, Andhra Pradesh (Finance Committee Agenda Item VIII)

Vide this Agenda, it was proposed to establish a new Regional Office and CoE at Visakhapatnam, Andhra Pradesh in view of the CBSE affiliated schools located in Andhra Pradesh as on date (approx. 1664) and to cater the educational needs of the schools located in the state of Andhra Pradesh which were earlier dealt by Regional Office, Chennai. With the establishment of new Regional Office, no new post will be sanctioned. It will be internally managed by re-allocation/ shifting of existing staff from other Regional Office/ HQ.

The justification in r/o above mentioned items was submitted and the Controlling Authority has now approved minutes of the above two agendas vide orders dated 07.10.2022 subject to exposure visits being funded by CBSE only for Central and State Govt. Affiliated schools, and not for any private School.
