	Legal Reserve Ratio is that minimum ratio deposits with banks which these banks are required to keep in the form of cash and specified liquid assets. In case of inflationary gap, the central bank can raise LRR thus reducing the lending capacity of the banks. As a result borrowings from banks decline leading to fall in aggregate demand.
