- 2. The testing has to be conducted in the presence of the Engineer In-Charge.
- 3. The Oil (New & Dehydrated) shall have to be got tested from the NDMC/Govt. laboratory by the agency at its own cost and the report shall be submitted to the Board.
- 4. The agency shall submit all test results in triplicate.
- 5. The work must be executed as per the CPWD specifications & Directions of the Engineer In-Charges.
- 6. The work has to complete within 10 days from the issue of the work order.
- 7. In case of delay a penalty @1% per week shall be levied.
- 8. In case the agency does not executed the work properly or deviate the directions given by the Engineer In-Charge, the work shall have to be redone as directed.
- 9. In case of inferior work, no payment shall be made concerning respective item.
