In case of any delay in supplying the desired report, on the part of the computing agency, the agency shall be liable to pay charges @Rs.2,000/- per day to the CBSE.
- 3. In case the computing agency is not able to execute the job in time or to the entire satisfaction of the CBSE, the Chairman, CBSE may allot the work to any other agency at any time.
