4. The material shall be supplied & installed within 15 days from the issue of the work order.
5. In case of slow progress/intentional delay, the Board shall have the right to rescind the contract & get the remaining work executed at the risk & cost of the defaulting agency.
6. No running payment shall be made. Payment shall be made within 15 days of the submission of the bill duly verified by the Site Engineer.
7. The defect liability period shall be six (6) months from the date of completion (DOC) & 10% of the bill amount shall be retained as security during the defect liability period which shall be released after its satisfactory completion.
8. The work shall be got executed through skilled manpower/technicians under the supervision of a qualified Supervisor/Foreman.
9. The agency shall be solely responsible for the safe custody of its material.
10. The agency shall ensure proper safety of its workers.
11. No T&P shall be provided by the Board.
12. The quantities mentioned in the schedule are tentative & may vary to any extent or even the item could be deleted. Hence, the actual quantity shall be worked out in consultation with the Board's Engineer.
