TERMS & CONDITIONS

- 1. Work shall be executed as per CPWD specifications and as per directions of the Engineer Incharge.
- 2. The duration of work would be one year.
- 3. The work shall be executed as per Complaint Register. Complaints of minor nature needs to be attended on the same day and complaints pertaining to masonry should be attended within 7 days.
- 4. Complaints pertaining to bursting of water supply pipe and electrical breakdown need to be attended within 4-6 hrs.
- 5. Running Bill would be paid every two months.
- 6. Measurements shall be done by the Contractor and checked by the JE (Civil). Work completion report of allottees are to be obtained by the Agency for Payment.
- 7. Items which are not covered under DSR would be paid on Market/Analyzed rates.
- 8. Space for storage would be provided to the Agency.
- 9. A sum of Rs. 30,000/- shall be deposited as security by the agency within 15 days after the award of work.
- 10. If the complaint is not attended within 7 days, the work shall got executed at the risk and cost of the Agency.
- 11. The agency which is awarded the work shall have to execute an agreement.
- 12. He workers deployed by the agency shall be polite, courteous and well behaved.
- 13. The agency shall provide uniform for the staff on duty.
- 14. Dismantled material shall be returned to the Board.
- 15. The Board can discontinue the contract at any time, if the performance is found unsatisfactory.
- 16. No T&P shall be supplied by the Board.
- 17. The Bio-data of the technicians deputed on duty shall be submitted. The antecedents of the workers must be got verified through the Police.
- 18. The agency shall ensure that none of his staff associates in unlawful activities.
- 19. The agency shall be solely responsible for any damage/loss to the Board's property/equipments.
- 20. The agency shall ensure that the wages and other benefits to the workmen are paid according to minimum wages and other benefits prescribed by the Govt. of U.P.
- 21. Workmen once posted shall be changed with prior permission of the Board.
- 22. The workmen must be experienced and qualified to undertake the repair work and must have atleast 5 years experience in the field.
