TENDER NOTICE

Sealed Tenders are invited from Allahabad, Kanpur, Varanasi and Lucknow based reputed transporters on behalf of the Secretary, C.B.S.E. for providing covered trucks in the months of March/April/May 2014 as per specifications given below:-

Approx 05 trucks of TATA 709/407/1210/1613 or Eicher 1109 or Equivalent model in a day will be required for sending and collecting the confidential materials in the States of Uttar Pradesh & Uttarakhand from Regional Office, Allahabad on different dates as per schedule of the Board. **“The Transporters having less No. of Trucks may also submit their Tenders and transporters who can provide covered trucks for single state are also eligible to submit their tenders”**.

The tender form along with terms & conditions can be obtained from the C.B.S.E. Regional office, 35-B, M.G. Marg, Civil Lines, Allahabad-211001 on any working day between 20.11.2013 to 09.12.2013 (10.00 AM to 03.00PM) on payment of Rs.500/- (non refundable) or can be downloaded from the Website www.cbse.nic.in and in such case cost of form should be enclosed in the shape of Bank Draft drawn from any Nationalized Bank in favour of **“Secretary, C.B.S.E. payable at Allahabad** only, with the tender form. It is pertinent to mention here that all Toll Tax in the way will be paid by the transporter. Also, if service is not found satisfactory by the board, the transporter will be black listed.

Interested transporters may submit their rates on prescribed tender form latest by 10.12.2013 upto 01.00 P.M. in a sealed cover superscribed **“TENDER FOR PROVIDING COVERED TRUCKS”** addressed to The Regional Officer, C.B.S.E., Regional Office, 35-B, M.G. Marg, Civil Lines, Allahabad either by post or they may drop tender personally in the Tender Box kept for the purpose at ground floor of Regional Office, Allahabad. Tenders will be opened on the same day i.e. 10.12.2013 at 03.00 P.M. in the presence of the tenderers who may like to be present. In no case trucks older than 04years will be accepted, tenderers must enclose copy of registration of trucks with the tender. An attested copy of PAN/TAN/Service Tax Registration must be enclosed with the Tender failing which tender will not be considered.

Tenders should accompany an Earnest Money of Rs.35,000/- (Rupees Thirty Five Thousand only) in the shape of Bank Draft only, drawn on any Nationalized Bank in favour of **Secretary, CBSE payable at Allahabad**. Before allotment of work, the Board reserves the right to inspect the condition of vehicle held by the agency. Tenders without Earnest Money and incomplete will be summarily rejected. The agencies who have already submitted their bids in response to earlier tender are at liberty either to revise their rates or to retain the same. The Competent Authority of the Board reserves right to accept or reject, any or all the tenders without assigning any reason.

TERMS & CONDITIONS

1. Rates should be quoted per Km. inclusive of all taxes in the prescribed form of Tender only.
2. There should not be any overwriting or erasing in the quoted rates and the terms and conditions of the contracts are to be signed by the Partner/Owner/Managing Director of the firm.
3. In case of default or abrogation of the condition stipulated, the EMD shall stand forfeited.
4. In case of delay in providing the vehicle by more than 6hours, a penalty of Rs.1000/- in each case will be imposed on the transporter as decided by the Competent Authority of the Board and the Board shall have the liberty to engage another transporter in case the truck is not provided by the approved Agency on the scheduled date and time and any loss to the Board shall be borne by the approved agency along with forfeiting the EMD.
5. The Transporter shall be fully responsible for damages or loss of answer books and full cost thereof will be recovered from the transporter. In addition to this further penalty as decided by the Chairman of the Board shall also be levied.
6. The delivery of answer books will have to be made safely and without any damage of any type and intact at the respective destinations. No extra charges will be payable, if any, for wrong delivery of consignment and the transporter shall be liable for all the damages and losses.
7. The Secretary of the Board is not bound to accept the lowest rates and reserves the right to accept tender in whole or in part or can reject it entirely without assigning any reason.
8. The successful tenderers shall have to provide the trucks strictly within stipulated time and date in the work order, failing which their earnest money will be forfeited and job will be assigned to the next lowest tenderer.
9. The payment will be made expeditiously after completion of work satisfactorily and submission of bills.
10. Approx 05 trucks in a day will be required of size TATA 407 or TATA 709 or TATA 1210/Eicher 1109 or TATA 1613 (covered) to be decided by the Board on different dates for sending and collecting the confidential materials in the **State of UP & Uttarakhand** from Regional Office, CBSE, Allahabad and back to Regional Office, Allahabad in the month of March, April & May 2014(As per requirement). The exact requirement of the trucks will be intimated at the time of placing order. The requirement of trucks may increase or decrease. Trucks should be provided at any place as per requirement and schedule of the Board. The Board will prefer TATA 709/Eicher 1109 due to large numbers of confidential packets.
