The chemical to be used and guarantee period of treatment should specifically be mentioned in tender.</li> <li>The EMD of Rs. 5,000.00 through bank draft in the name of Secretary, CBSE, Ajmer payable at Ajmer may be enclosed with the quotation, failing which the quotation will not be considered by the office.</li> <li>The Secretary of the Board has the right to accept or reject any quotation without assigning any reason.</li> <li>The successful firm will have to give an undertaking to the effect that the pest control treatment given will remain effective for a minimum period of five years, failing which the firm will either provide pest control treatment again or refund the cost of treatment in Board's account.</li> <li>The room area can be inspected during any working day from 9:00 am to 5:00 pm.</li> <li>All taxes will be deducted as per Govt.
