Sealed tenders are invited from **Allahabad, Kanpur, Varanasi and Lucknow** based reputed transporters on behalf of the Secretary, C. B. S. E. for providing covered vehicles in the months of March/April, 2012 as per specifications given below: -

Approx 07 trucks of TATA 709/407/1210/1613 or Eicher 1109 or Equivalent model in a day will be required for sending and collecting the confidential materials in the States of **Uttar Pradesh & Uttrakhand** from Regional Office, Allahabad on different dates as per schedule of the Board. **“The Transporters having less No. of Trucks may also submit their bids & Transporters who can provide covered vehicles for single state are also eligible to quote their bid”.**

**TERMS & CONDITIONS**

1. Rate should be quoted per Km. inclusive of all taxes in the prescribed form of Tender only.
2. There should not be any overwriting or erasing in the quoted rates and the terms and conditions of the contracts are to be signed by the Partner/Owner/Managing Director of the firm.
3. In case of default or abrogation of the condition stipulated, the EMD shall stand forfeited.
4. In case of delay in providing the vehicle by more than 6hours, a penalty of Rs.1000/- in each case will be imposed on the transporter as decided by the Competent Authority of the Board and the Board shall have the liberty to engage another transporter in case the vehicle is not provided by the approved Agency on the scheduled date and time and any loss to the Board shall be borne by the approved agency along with forfeiting the EMD.
5. The transporter shall be fully responsible for damages or loss of answer books and full cost thereof will be recovered from the transporter. In addition to this further penalty as decided by the Chairman of the Board shall also be levied.
6. The delivery of answer books will have to be made safely and without any damage of any type and intact at the respective destinations. No extra charges will be payable, if any, for wrong delivery of consignment and the transporter shall be liable for all the damages and losses.
7. The Secretary of the Board is not bound to accept the lowest rates and reserves the right to accept tender in whole or in part or can reject it entirely without assigning any reason.
8. The successful tenderers shall have to provide the truck(s) within 1-2 days time from the date of requisition by the C. B. S. E., failing which their earnest money will be forfeited and job will be assigned to the next lowest tenderer.
9. The payment will be made expeditiously after completion of work and submitting the bills to the Board's satisfaction.
10. Approx 07 trucks in a day will be required of size TATA 407 or TATA 709 or TATA 1210/EICHER 1109 or TATA1613 (covered) to be decided by the board on different dates for sending and collecting the confidential materials in the **State of UP & Uttrakhand** from Regional Office, Allahabad and back to Regional Office, Allahabad in the month of March & April 2013. The exact requirement of the vehicles will be intimated at the time of placing order. The requirement of vehicle may increase or decrease. Vehicle should be provided at any place as per requirement and schedule of the Board. The Board will prefer TATA 709/EICHER 1109 due to large number of confidential packets.
