Term& Conditions

- 1. The rate shall be valid for 90 days from the date of opening of bids.
- 2. The time is the essence of this contract, hence the supply & installation has to be completed within 15 days from the date of work orders.
- 3. The agency must have e-mail id so that complaints are lodged through e-mail & lodged telephonically as well.
- 4. The Window Ac's must confirm the specifications, the guarantee/ warrantee cards & technical broachers shall be supplied alongwith the delivery.
- 5. The consignment is to be supplied in manufacturer's original packing only.
- 6. During the guarantee period, the complaints lodged be attended within 6-8 working hrs. but at the most within 24 Hrs.
- 7. Payment shall be released after 10 days of satisfactory installation & commissioning.
- 8. In case of defect involving replacement of the compressors, the work has to be completed within 72 hrs.
- 9. In case, the A.C. supplied is troubling again and again, the agency shall be required to replace altogether.
- 10. The quantity mentioned in the tender notice is tentative & may increase/decrease.
- 11. In case of delay in supply & installation, a penalty @ 1% per week shall be levied.
- 12. In case any clarification is required, you may contact on Tel No. 0612-2295048.
- 13. The Board also reserves the right to bifurcate the supply order & assign the work to two firms.
- 14. In case of inordinate delay without any valid reason, the Board shall have the right to rescind the work and forfeit the EMD/P.G.
- 15. Material will be supplied at the doorsteps of CBSE office at Sheikhpura, Bailey Road, Patna for which no charges will be claimed.
