Terms & Conditions

- 1. The work shall be executed as per the approved specifications and CPWD norms.
- 2. The decision of the Engineer-in charge in regard to the work shall be final and binding on the contractor. Lay-out Plan shall be drawn and got approved.
- 3. The work is Time -Bound, hence time is the essence of the contract.
- 4. The work is to be completed within 10 days from the date of award of work.
- 5. All the materials i/c the colour scheme of powder coating, fabric and pre-laminated particle board shall be got approved from the Engineer-in-charge.
- 6. The Roller Blind mechanism must be guaranteed for a period of 5 years.
- 7. In case of any complaint, the agency shall be bound to attend the same within 24 hrs.
- 8. Payment shall be made within 10 days after satisfactory completion of work.
- 9. No T & P shall be provided by the Board.
- 10. Scaffolding shall be arranged by the Contractor.
- 11. The work shall be executed under the strict supervision of the agency's qualified Supervisor/Engineer. The joinery must be perfect & flush imparting neat finishing without any kinks/burrs.
- 12. The measurements shall be recorded jointly.
- 13. In case of delay, a penalty @ 1% per week shall be levied subject to a max of 5%.
- 14. In case of poor workmanship, the Board shall have the right to rescind the contract and get the work executed through any other agency at the risk & cost of the defaulting contractor.
- 15. In case the work is kept suspended without any valid reason, the Board shall be free to get the remaining work executed through any other agency.
- 16. The contractor shall be required to provide adequate safety for its workers and the Board shall not h
