EXTENSION OF LAST DATE FOR SUBMISSION OF TENDER

In continuation of notification no. CBSE/CU/13/Finger Prints dated: 20.12.2013, an open tender was floated for inviting Tenders For **"PROVIDING SERVICES OF SCANNING OF FINGER PRINTS AND CAPTURING OF DIGITAL PHOTOGRAPHS"** of the examinees of AIPMT 2014, it is informed to all concerned that the last date of submission of Tenders has been extended to 21st January 2014 instead of 15th January, 2014.

The final date of submission of tender will now be **21st January 2014 till 2:00 p.m.**

The Technical Bids will be opened on 21st January 2014 at 3:00 p.m. in the presence of the Bidders.

The clarifications to the queries raised by the tenderers in the pre-bid meeting is attached at Annexure-'A'.

Those bidders who have submitted the tender may re-submit the same with modification as per clarification given at Annexure-'A' with the superscription on the envelope "REVISED TENDER". The security deposit submitted with earlier tender will be considered for the revised tender.

JOINT SECRETARY (OSD) / AIPMT

- A. The last date of submission of tender is extended upto 21st Jan 2014 till 2.00 PM.
- B. The following sentences may be added/modified in the Scope of work under points 4.1 and 4.2

4.1

- The agency will have to ensure that sufficient number of FBI Grade grey inkless pads are provided at the Board to put the finger print impression on the attendance sheet provided by the Board. The Paper quality and print format shall be provided by the agency.
- **The image of finger print shall be scanned by the agency on 600 dpi grey scale in JPG format and stored in JPG as well as raw data format as prescribed by NIST for finger prints.**
- The agency will also provide CBSE the roll no. wise image of finger prints in JPG format as well as in raw data format as described by NIST in a database along with path of the image file.
- The agency will have to depute adequate staff and biometric devices loaded with finger prints captured during the Examination and do the verification process at the Medical colleges where the candidates shall be admitted through merit list of AIPMT. The agency should ensure that the scanned image stored in the raw data format as prescribed by NIST should be recoverable and verified at the Medical colleges where the candidates are admitted through merit list of AIPMT. The expenditure on this shall be borne by the agency.
- For any court case registered, the agency shall be responsible to provide authenticity/evidences of the image provided to fully acceptable under Indian Evidence Act.

4.2

- **The digital image of photograph shall be captured on 600 dpi grey scale in JPG format and stored in JPG as well as raw data format as prescribed by NIST for photographs.**
- The agency will also provide CBSE the roll no. wise image of photograph in JPG format as well as raw data format in a database as per requirement of the Board.
- The agency will have to depute adequate staff and biometric devices loaded with photographs captured during the Examination and do the verification process at the Medical colleges where the candidates shall be admitted through merit list of AIPMT. The agency will have to ensure that the captured image stored in the raw data format as prescribed by NIST should be recoverable and provide facial recognition at the time of verification at the Medical colleges where the candidates are admitted through merit list of AIPMT.
- For any court case registered, the agency shall be responsible to provide authenticity/evidences of the image provided to fully acceptable under Indian Evidence Act.

C. Under Eligibility conditions, the statement 'Supported by Financial Statements, Balance sheet may be read as 'Supported by Financial statements, Audited Accounts'.

D. Under Eligibility conditions, 7 (b) may be read as follows:

The agency has to quote for all States for capturing of Photographs.

E. Point 7 in Tender document may include the following points.

- The agency shall have to maintain time schedule strictly. Adherence to the time schedule strictly shall be the essence of the contract.
- The agency shall depute sufficient number of man power/staff necessary for taking photograph of the candidates during the course of the examination in each of the cities to cover every centre within the stipulated time. The exam is held in one shift of 3 hours duration.
- The agency shall depute sufficient number of man power/staff necessary for taking photograph of the candidates during the course of the examination such that 125 candidates are photographed by one person and that the candidate is not disturbed.
