Terms & Conditions

- 1. The work shall be executed as per the approved drawings & the specifications.
- 2. The approved brands are Godrej, Delite Hi Tech, Duaco, Howarth & Metafab for Schedule. The authorized agency/manufacturer may apply.
- 3. Time is the essence of the contract, hence the work is to be completed within 30 days after the issue of the work order.
- 4. The colour pattern shall be got approved through the Engineer In charge.
- 5. The joinery of the partitions & the work-stations has to be perfect Inline, plumb & frames grouted wherever feasible.
- 6. In case of any damage to the wall/ floor in the bldg., the agency shall have to make good the same.
- 7. In case of delayed execution of work, penalty @ 1% per week shall be levied.
- 8. No running/ advance payment shall be made to the agency. Final payment shall be released within 10 days of the submission of the bill.
- 9. Security equivalent to 10 % of the value of work shall be retained for a period of six months & released provided there is no deficiency noticed during the defect liability period.
- 10. No T & P shall be issued by the Board.
- 11. The agency must employ its bonafide, honest & well behaved workers. In case of any incident of theft, burglary, mischievous deeds, damage/loss to the Board's property by the workers of the agency, it shall be solely responsible & the loss shall be borne by it.
- 12. In case any dispute, Chairman CBSE shall be the sole Arbitrator & his decision shall be binding on both the parties.
