- 1. The work must be executed as per the specifications and best Engineering practice.
- 2. Rates must be quoted both in figures & words.
- 3. Rates must be inclusive of all taxes, cartage, freight, octroi etc. etc. Nothing extra shall be payable on any account.
- 4. Cutting/overwriting should be avoided. In case of any cutting/overwriting, the same must be initialed/authenticated.
- 5. Rates are to be quoted on the prescribed format.
- 6. CBSE reserves the right to deviate the quantity. Any item can be deleted if not required as per site conditions. Payment shall be made on the basis of the measurements.
- 7. ALL T & P shall be arranged by the agency at their own cost.
- 8. In case of any damage to the structure, the same shall be made good by the agency.
- 9. The rates quoted must be inclusive of all Taxes & Installation Charges.
- 10. The agency shall be bound to complete the work within 20 days from the issue of the work order.
- 11. In case of delayed execution a penalty @ 1% per week shall be levied.
- 12. The agency selected for the work shall deposit a performance guarantee equivalent to 10% of the total value of the work. It can be submitted in the form of the Bank Guarantee.
- 13. In case of slow progress & the Board put to any financial loss, the CBSE shall invoke the Bank Guarantee or even forfeit the EMD.
- 14. The agency shall submit all the Brochures to the Engineer-In-Charge/Regional Officer.
- 15. All materials brought to site shall be conforming to the specifications. In case any unapproved material is found at site, the same shall be removed by the agency at his own expense immediately.
- 16. 5% of the basic value of bill shall be retained as defect liability for a period of six months effective from the date of completion. On observing satisfactory performance, the same shall be refunded without interest.
- 17. No running payment is permissible however, the final bill would be processed & cleared within 15 days from the date of its submission.
- 18. The System installed must be structurally guaranteed for a period of five year from the date of completion.
- 19. The agency shall be required to depute its Erection Engineer within 48 hrs., in case any weakness of joinery is noticed.
