**TERMS & CONDITIONS**

1. Sealed tender, under two bid system complete in all respect along with a bank draft for Rs.3,00,000/- valid for a period of 6 months towards earnest money drawn in favour of "The Secretary, CBSE, Delhi" placed in Technical bid envelopes should be dropped in the Tender Box kept with Security Guard at Ground Floor, CBSE, Preet Vihar Delhi latest by 2:30 P.M on 26/08/2011. In complete/conditional/late tenders or those without earnest money will be rejected. Technical Bids will be opened at 3:00 P.M in the presence of representatives of the tenderers, who may like to be present and financial bids of only technically qualified tenderers will be opened later on and date will be informed to them. There should not be over writing or amendment in the rates quoted, the terms and conditions of the contract. All the forms should be duly signed with seal of the firm.
2. Agencies having IATA membership and having a minimum turn over of Rs.50 Lac per annum during the last three years only need to apply. Agency must have registered with Government Agencies viz. Ministry of Tourism and Directorate of Sales Tax, etc.
3. The agencies must have experience of booking Rail/Air tickets for Government and Autonomous organization for similar volume/nature.
4. EMD of unsuccessful bidders will be returned without interest. EMD of successful bidders will be retained and will be converted into security deposit and remain with the Board during the period of contract.
5. The EMD of successful tenderers will be forfeited in case he fails to accept the order.
6. The agency may explore the possibility of Economy/Promotional apex fare(s) at the first instance for making the Air/Rail booking, in case more than three tickets are booked for any sector it must be considered as bulk bookings and accordingly discount would be applicable for bulk bookings.
7. No advance payment will be made for any kind of booking. However, the Board will arrange for expeditious payment after actual journey is performed.

8. **PENALTY CLAUSE:** In case of agency is not able to supply tickets on time, the penalty will be as under: -
- 2% in case of bulk air tickets booking on the value of tickets not provided by the agency.
  - 5% in case of individual air tickets booking.
  - In case of Railway tickets, reservations charges will not be payable.

*# These conditions will come into force only where the agency is at fault and not under unforeseen circumstances*

9. No revision of rates will be permitted during the period of the contract. The Rate contract shall be valid for a minimum period of one year from the date of notification of the rate contract. The contract can be extended further on year to year basis for a maximum period of 03 years on mutually agreed Terms & Conditions.
10. In case of unsatisfactory services i.e. non-booking of the Air/Railway tickets timely as per requirement of the Board, the contract shall be terminated by giving notice of 10 days.
11. In case of any dispute or abrogation of conditions stipulated, the decision of the Chairman of the Board in all the matters concerning tender shall be final and binding upon the tenderer.
12. In addition to discounts mentioned in rates quoted, the agency shall intimate and transfer all additional discounts that are given by Authorities/Airlines.
13. The legal jurisdiction will be the Courts of Delhi/New Delhi only.
